### 1. Grant of Rights

- **1.1 Release of Rights:** The Talent grants the Producer and its affiliates, successors, and licensees the irrevocable right to use the Talent's likeness, image, voice, and performance (the "Content") in connection with the following project or production (the "Project"):

- **2.1 Compensation:** In consideration for the rights granted in this Agreement, the Talent will receive:

  - **4.2 Waiver of Right to Inspect:** The Talent waives the right to inspect or approve the final version of the Content, including any written copy or media format in which the Content may appear.

### 5. Representations and Warranties

- **5.1 Talent's Representations:** The Talent represents and warrants that:
    - a. The Talent is over the age of majority (or has a parent/guardian co-sign this form if underage).
    - b. The Talent has the full legal right to enter into this Agreement and to grant the rights described herein.
    - c. The Talent's performance and appearance do not infringe upon the rights of any third party.
  - **5.2 Producer's Representations:** The Producer agrees to use the Talent's likeness, performance, and image in accordance with all applicable laws and regulations.

### 6. Indemnification

- **6.1** The Talent agrees to indemnify and hold harmless the Producer from any claims, damages, or liabilities arising out of any breach of the Talent's representations and warranties under this Agreement.

### 7. Term and Termination

- **7.1 Term:** The rights granted to the Producer under this Agreement shall continue indefinitely, unless otherwise specified, and are irrevocable by the Talent.
  - **7.2 Termination:** The Producer may terminate this Agreement at any time by providing written notice to the Talent. The Talent may not revoke this Agreement after signing.

## 8. Governing Law

- **8.1** This Agreement shall be governed by and construed in accordance with the laws of the State of **[State]**, without regard to its conflict of law principles.
